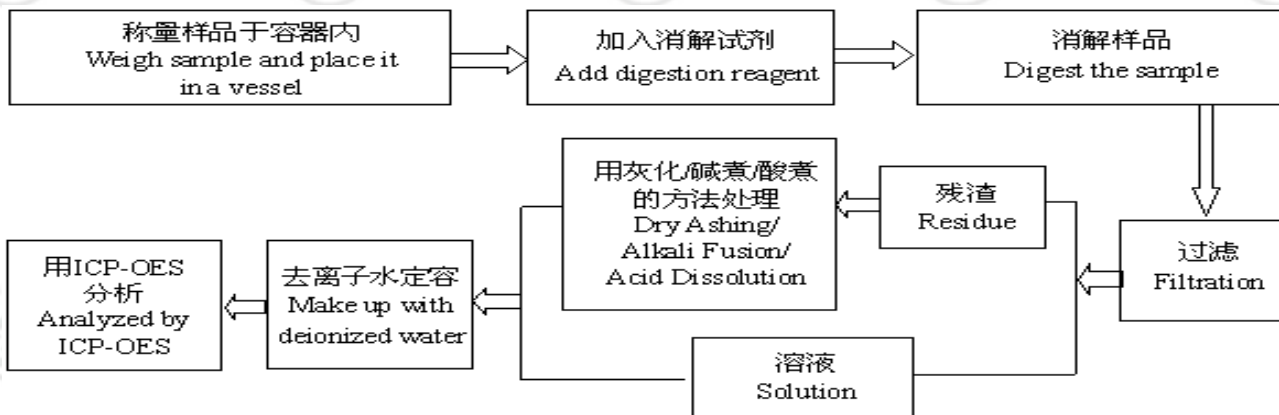

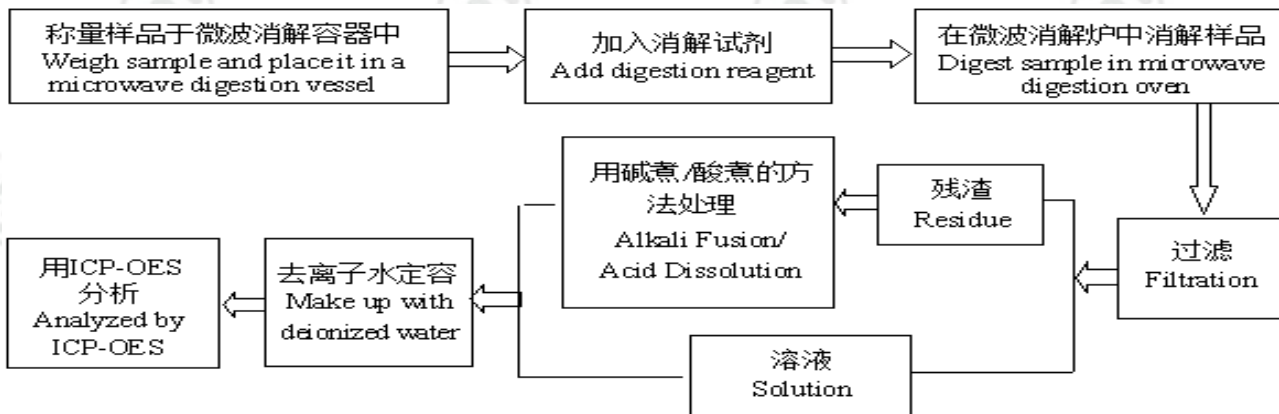

#### Lead(Pb), Cadmium(Cd), Chromium(Cr)



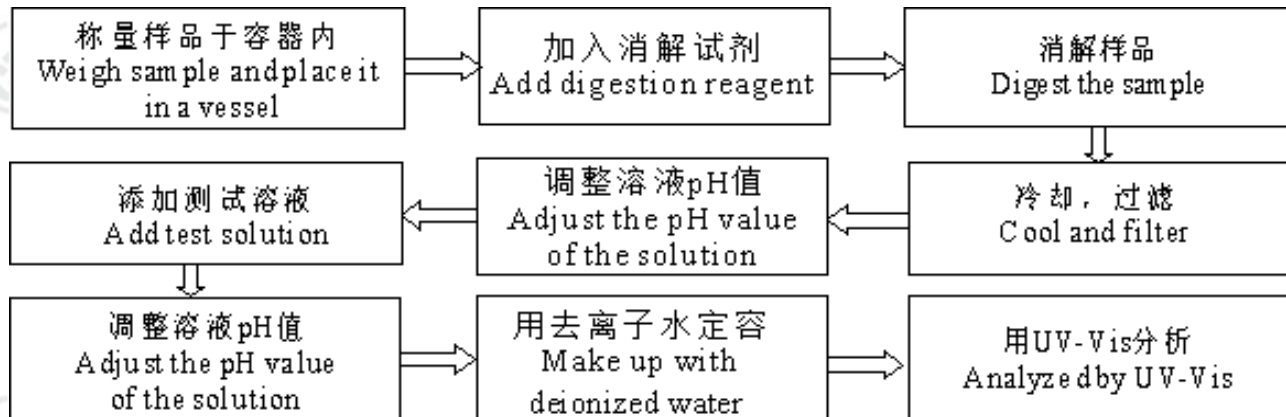

#### Hexavalent Chromium(Cr(VI))



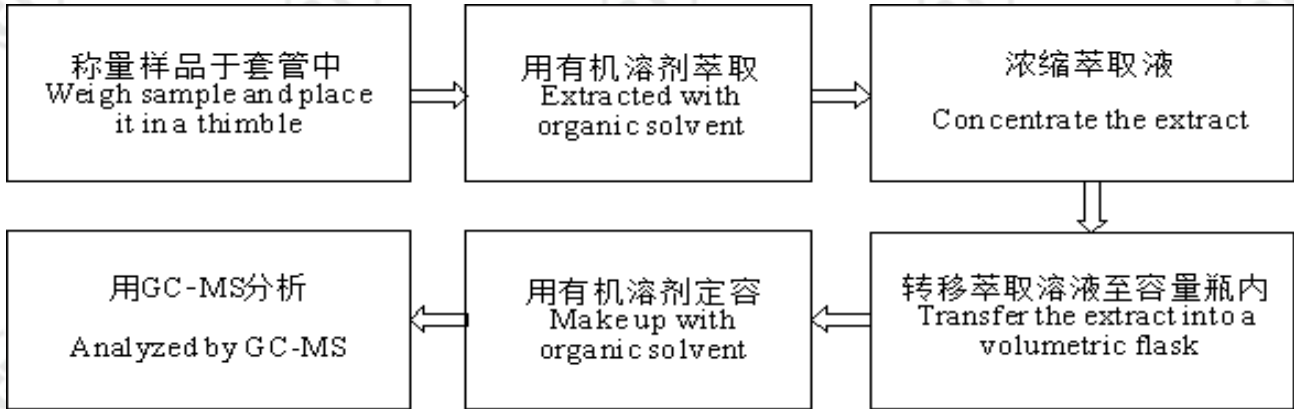

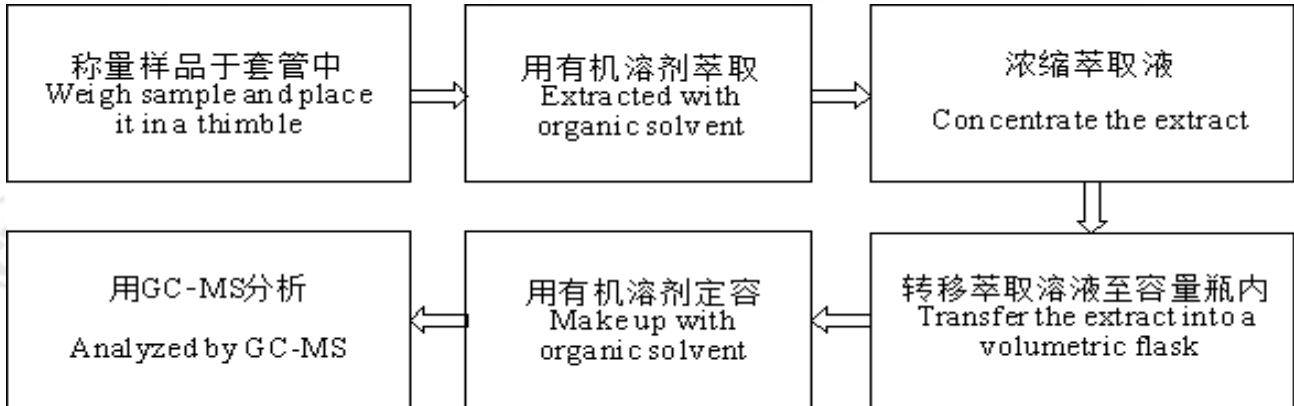

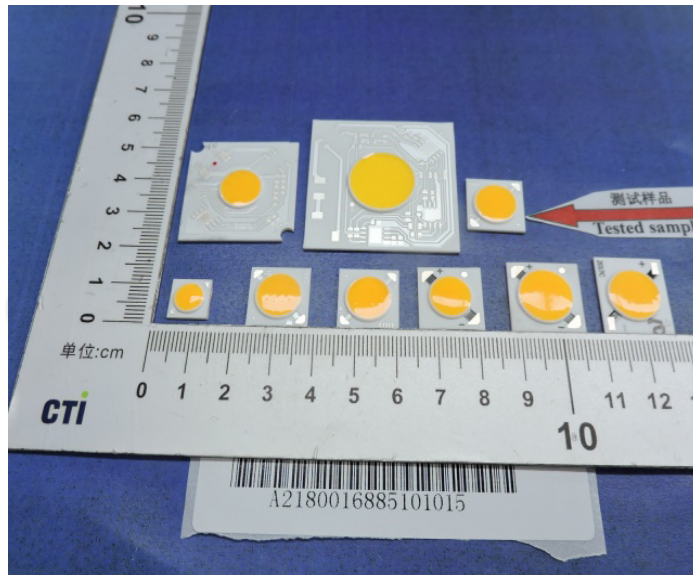
